

**NOTICE FOR ENROLLMENT FOR THE POST OF 18 NOS OF PART-TIME PLATOON HAVILDAR
(VOLUNTEERS) IN MEGHALAYA BORDER WING HOMEGUARDS BATTALION**

1. Applications are invited in the **Prescribed Standard Form** from Home Guards Volunteers who are deployed/engaged with various Requisitioning Agencies for a total period of 5(five) years, i.e. 1825 days and who are Indian citizens and are domiciled in the state of Meghalaya for enrolment into **18 posts of Part-Time Platoon Havildars (Volunteers)** In Meghalaya Border Wing Home Guards Battalion, to be deployed under 'Wages', Highly Skilled Category at the rate as prescribed by the **Department of Labour, Employment & Skill Development, Govt. of Meghalaya** from time to time, including the Risk allowance as prescribed by the State Government, as monthly Honoraria.

The Upper Age limit of the applicants should not exceed **50 years** as on **11th March 2026**.

The deployment period is only for **1 (one) year**, which may be extended based on the performance of the volunteers in the task assigned to them.

The deployment will be purely temporary and voluntary, and no volunteer can claim regularization or permanent retention. The deployed volunteers can be dismissed/terminated at any time without assigning any reasons thereof.

2. The last date for receipt of Applications is **6th April 2026**. Applications received by hand or by post after the last date will not be considered under any circumstances. Incomplete applications or applications not accompanied by the required certificates or testimonials will be rejected, and no correspondence in this regard will be entertained.
3. **General Instructions:-** The application filed in the standard form should be submitted along with the attested copies of the following certificates/ documents :
 - I. 2(two) copies of a recent passport-size photograph, one of which is to be pasted in the Standard Form.
 - II. Educational Qualification Certificate.
 - III. Birth Certificate or Age Certificate as per school records.
 - IV. EPIC card of Meghalaya.
 - V. Home Guards Basic Training Certificate.
 - VI. Medical Fitness Certificate from any Authorized Government Medical Practitioners/Institutions.
 - VII. The Deployment Period Certificate issued by the District Commandant/ Officers Commanding District Training Centre/ Deputy Controller of Civil Defence in a prescribed format should also be submitted along with the Application Form.
 - VIII. Applications completed in all respects and accompanied by self-attested copies of certificates and testimonials should be submitted to their respective District Home Guards Offices/Officers Commanding District Training Centre/Civil Defence Offices from where they are being deployed with various Requisitioning Agencies.

4. The Personal Interview of the Eligible Home Guards Volunteers will be conducted in **Tura and Shillong** centres.

The successful/selected Volunteers have to serve anywhere in the remote border areas of Khasi, Jaintia & Garo Hills bordering Bangladesh.

N.B- No separate intimation regarding interviews will be sent. It shall be the responsibility of the candidates/volunteers to check the selected list and appear for the interview on the dates as notified on the Departmental Notice Boards & office website.(meghomeguards.gov.in)

5. Important Points –

- I. The Department shall not be responsible for any damage/injury to the volunteers during the enrolment process.
- II. The Volunteers should come duly prepared to stay for 2/3 days under their own arrangements, and no TA/DA will be admissible for the journey or stay.
- III. The Volunteers should carry valid ID cards for identification and present the original documents to the Board during the Personal Interview.
- IV. Canvassing directly or indirectly will lead to the disqualification of the candidate/volunteer, and any volunteer found offering a bribe to anyone involved in the enrolment process or in a position of authority shall be disqualified and/or be prosecuted.
- V. Department reserves the right to cancel the enrolment process wholly or partially without assigning any reasons thereof.
- VI. State Reservation Policy/Roaster will not be applicable in this Enrolment procedure since the deployment will be purely voluntary
